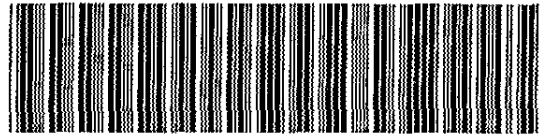

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of the corporation is MUSIC SPOT PRODUCTIONS, INC.

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE

The general purposes for which the corporation is organized are:

1. To own and operate a business involving music production and graphics.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act.
