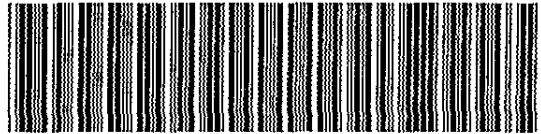



ARTICLE ONE

The name of the corporation is Corproserv, Inc., and its principal office is at 636 Sunset Drive, South, St. Petersburg, Florida 33707

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is to conduct any activities permitted under Florida Law. Further, the purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.
