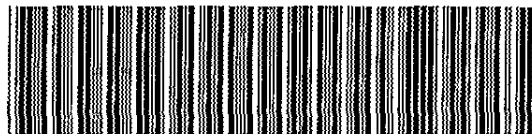




#### ARTICLE VIII - INDEMNIFICATION
