



#### ARTICLE I - NAME

The name of this corporation is Joyce's Art Gallery, Inc. The address for the corporation is 14385 Walsingham Road, Unit B, Largo, Florida 33774.

#### ARTICLE II - DURATION

This corporation shall exist for a perpetual period.

#### ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated.

#### ARTICLE IV - CAPITAL STOCK

#### ARTICLE XII - POWERS

This corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act.

#### ARTICLE XIII - MEETINGS BY CONFERENCE TELEPHONE

Members of the Board of Directors may participate in (special) meetings of the Board of Directors by means of conference telephone as provided by law, but (regular) meetings of the Board of Directors must be attended in fact in person by each Director.

#### ARTICLE XIV - INDEMNIFICATION

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

#### ARTICLE XV - AMENDMENT
