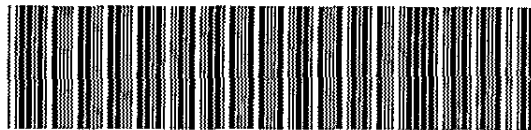



The undersigned, for the purpose of forming a corporation, hereby adopt the following Articles of Incorporation.

ARTICLE ONE
NAME

The name of the Corporation is Netstar-USA, Corp., 2212 E.4th Avenue, Tampa, FL 33605.

DURATION

The term of existence of the Corporation is perpetual.

PURPOSE

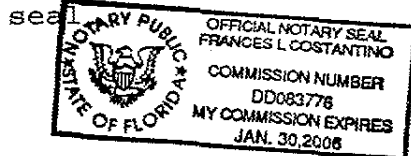


