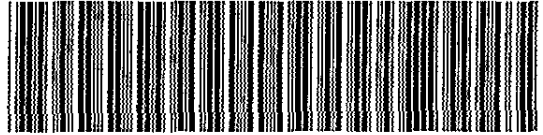

NAME

The name of this corporation is KOHLHASE & MOORE ENTERPRISES, INC.

ARTICLE II

DURATION

This corporation shall have perpetual existence.

ARTICLE III

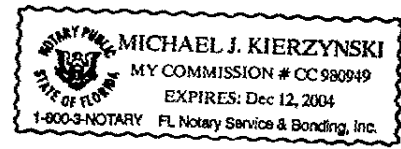
