

ARTICLES OF INCORPORATION OF Kim Alexis Pro, Inc.

ARTICLE I CORPORATION NAME

The name of this corporation is Kim Alexis Pro, Inc.

ARTICLE II PURPOSE

This corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.
