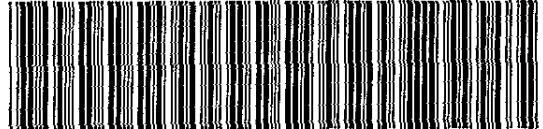

I. NAME AND CORPORATE STATUS

The name of the corporation is **Creative Construction & Renovation, Inc.**, a for-profit corporation formed under the Florida General Corporation Act.

Further qualifications for Directors may be added by the Bylaws of this Corporation.

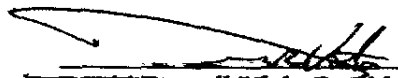
VII. INDEMNIFICATION

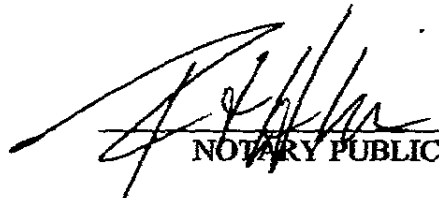
