

WE, THE UNDERSIGNED HEREBY ASSOCIATE OURSELVES
TOGETHER FOR THE PURPOSE OF BECOMING A CORPORATION
UNDER THE LAWS OF THE STATE OF FLORIDA PROVIDING FOR
