ARTICLE I

NAME

The name of this corporation is: J & J INTERNATIONAL MARINE SUPPLY & SERVICE, INC.

- (i) To sell, manage, improve, develop, assign, transfer, convey, lease, sublease, pledge or otherwise encumber the lands.
