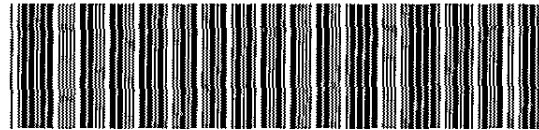

The name of this corporation is: THOMAS P. McLENNON, J.D., P.A.

Article II - Duration

This corporation shall have perpetual existence.

Article III - Purpose

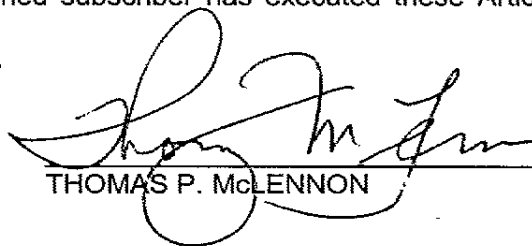

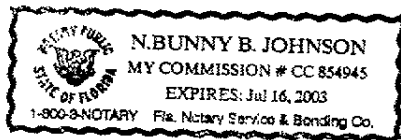
