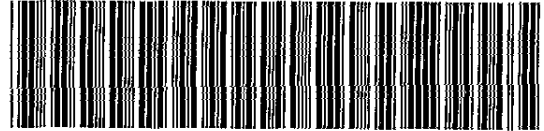

**ARTICLES OF INCORPORATION

Article I- Name

The name of the Corporation shall be Radey Thomas Yon, P.A.

Article II- Term

The corporate existence of the Corporation shall continue perpetually unless and until dissolved in accordance with law.

Article III- General Purposes

The Corporation is organized under Florida law as a professional corporation for the purpose of rendering legal services. In connection its legal services business, the Corporation reserves the right to transact any and all business activities that are not prohibited to a professional legal services corporation by the laws, rules or regulations applicable to the Corporation or its professional business, Law practice.

The affairs of the Corporation shall be managed by a Board of Directors consisting of not fewer than one person, the exact number to be determined from time to time in accordance with the Bylaws.

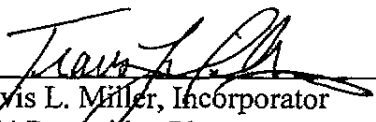
Article VII- Officers

The Corporation is authorized to indemnify its directors and officers to the fullest extent permitted by law.

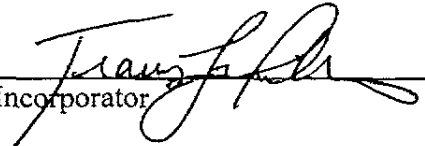

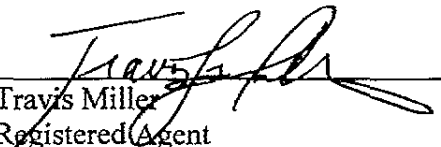
**CERTIFICATE DESIGNATING REGISTERED AGENT
