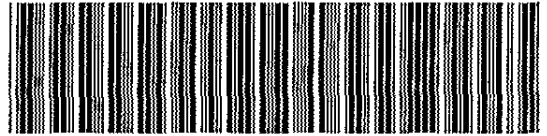

NAME:


