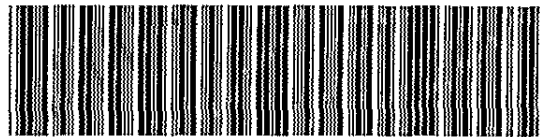

ARTICLE I

NAME

CTJ Investment, Inc.

ARTICLE II

PRINCIPAL OFFICE

The principal office and mailing address of this corporation is 1773 Marshside Drive, Jacksonville, Florida 32250.

ARTICLE III

CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of common stock with a par value of Ten Cents (\$0.10) per share, which shares shall be and hereby are designated as "Common Shares." 
