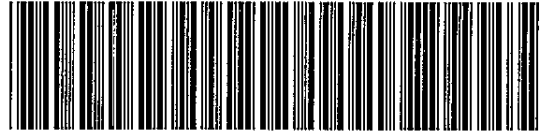

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is D'S SPORTS BAR, INC., and the principal address and principal place of business is 2716 EASTER PLACE, HOLIDAY, FLORIDA 34691.

ARTICLE II - REGISTERED OFFICE AND AGENT
