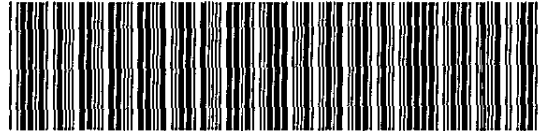

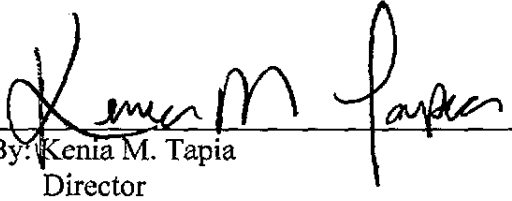

THIRD: The date of each amendment's adoption: **November 17, 2003.**

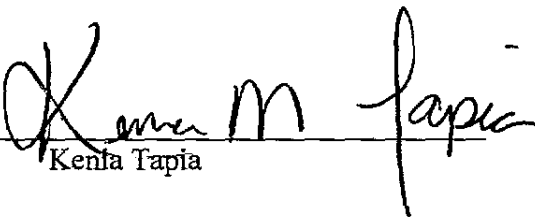
