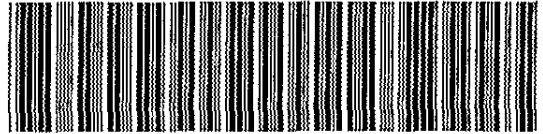

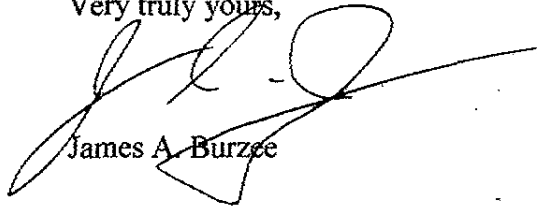

**ARTICLE I - NAME**

The name of this corporation is **VOODOO INVESTMENTS, INC.**

**ARTICLE II - PRINCIPAL OFFICE**

The address of the principal office and the mailing address of the corporation is 901 Euclid Avenue, Orlando, Florida 32806.

**ARTICLE III - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

**ARTICLE IV - PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may after be amended.

**ARTICLE V - CAPITAL STOCK**

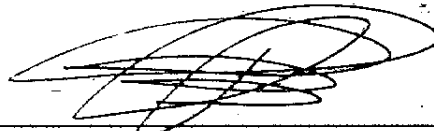
#### **ARTICLE X - INDEMNIFICATION**

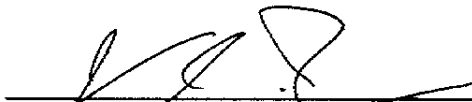
