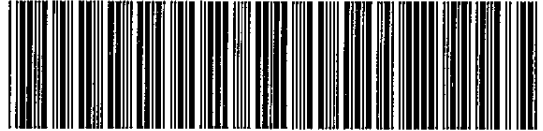

**ARTICLES OF INCORPORATION
OF
RGB EXPRESS, INC.**

The undersigned incorporator, having legal capacity to contract, hereby forms a corporation for profit under Chapter 607 of the laws of the State of Florida.

ARTICLE I -- NAME

The name of the corporation shall be:

RGB EXPRESS, INC.

The address of the principal office of this corporation shall be: P.O. Box 060368, Palm Bay, FL 32906-0368, and the mailing address shall be the same.

ARTICLE II -- NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, territory or nation.

ARTICLE III -- CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is one hundred (100) shares of common stock having no par value per share.

ARTICLE IV -- REGISTERED OFFICE & AGENT






