The undersigned, for the purpose of forming a corporation under the Florida Business Act, do hereby adopt the following articles of incorporation.

ARTICLE I - NAME

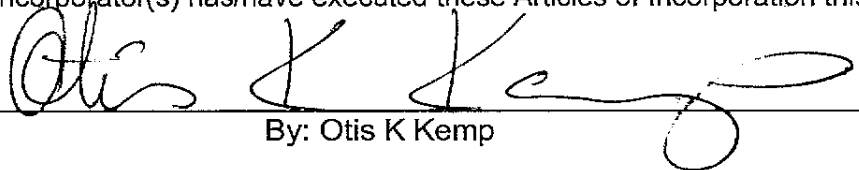
