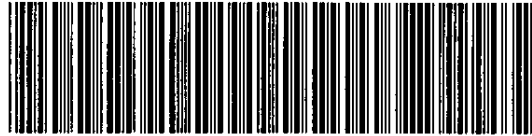

To Whom this may concern,


We officially closed our small home based business on June 30, 2009.
