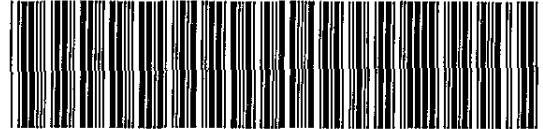

ARTICLE I – NAME

The name of this corporation is **CHASTAIN SECURING, INC.**

ARTICLE II – DURATION

The duration of this corporation shall commence upon acceptance and shall be perpetual.
