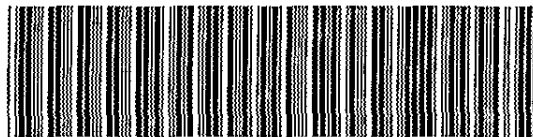

THE FOLLOWING ARTICLES OF INCORPORATION:

ARTICLE 1
NAME

INDEMNIFICATION

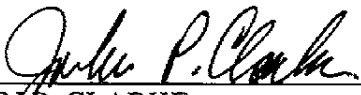
