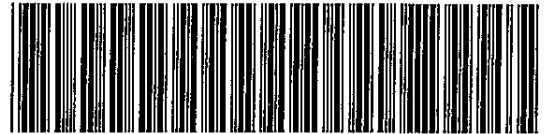

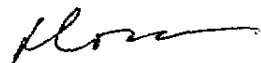

I, E.T. BAHRE, being of legal age do hereby authorize the formation of a corporation under the laws of the State of Florida.

ARTICLE I.

The name of this corporation shall be SKYTECH CONSOLIDATED, INC.
