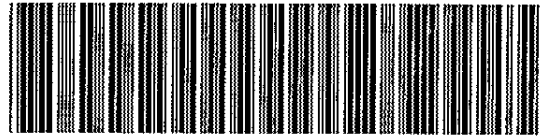

**ARTICLE I**  
**CORPORATE NAME, PRINCIPAL OFFICE**  
**AND MAILING ADDRESS**

The name of this Corporation shall be: **LEHR CONSULTING, INC.**, with its principal office located at 2237 Doster Drive, , New Smyrna Beach, Florida 32168 and its corporate mailing address being P. O. Box 856, New Smyrna Beach, Florida 32170.

**ARTICLE II**




