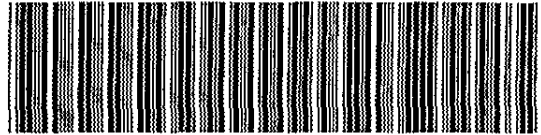

ARTICLE II - NAME OF CORPORATION

The name of this corporation is SEAGRAPE FLYING, INC.

ARTICLE II - PURPOSES

This corporation is organized for the purpose of transacting any or all lawful business pursuant to the provisions of Chapter 607, Florida Statutes.


