Pursuant to the provisions of section 607.1006, Florida Statutes, this corporation adopts the following Articles of Amendments to its Articles of Incorporation:

FIRST: Article 7 of the Articles of Incorporation of INTEGRAL, INC. states:

The maximum number of shares that this Corporation is authorized to have outstanding at any time is **SEVEN THOUSAND FIVE HUNDRED** (7,500) shares of common stock, each having the par value of ONE DOLLAR (\$1.00).

**SECOND:** The corporate capitalization of INTEGRAL, INC. will be amended to state:

The maximum number of shares that this Corporation is authorized to have outstanding at any time is **FIFTY MILLION** (50,000,000) shares of common stock, each having the par value of **ONE TENTH OF** A CENT (\$0.001).
