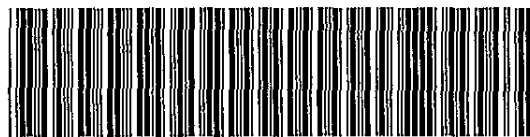

Article I- Name

The name of this corporation is JOEL MARGULES, P.A. The initial street address is 721 Georgia Avenue, Panama City, FL. 32404 and the mailing address is Post Office Box 16206, Panama City, FL 32406.

Article II-Duration

This corporation shall exist perpetually, commencing with the date of execution and acknowledgment of these Articles.

Article III- Purpose

The general nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:

a. To engage in every aspect of the practice of law, and all its fields, as are engaged in by attorneys at law.

be. To engage and render the professional services involved only through its officers, agents and employees who shall be attorneys at law in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as this corporation.

c. To do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.

d. To carry on any other lawful activity permitted under Chapter 621 of the Florida Statutes and not specifically precluded by any provision of Section 621.08 thereof.

Article IV- Capital Stock

This corporation is authorized to issue one hundred (100) shares of One dollar (\$1.00) par value common stock.

Article V-Initial Registered Office and Agent

Article VI-Initial Board of Directors

Article X- Preemptive Rights

his pro rate share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

Article XI-Amendments of Articles of Incorporation

These Articles of Incorporation may be amended in any manner and by way of any procedure provided by law.

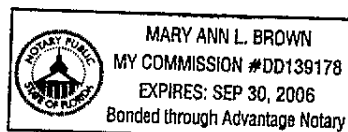

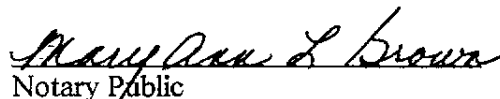
