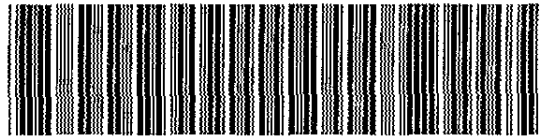

ARTICLES OF INCORPORATION

OF

ACE STAIR PARTS, INC.

ARTICLE I. Name and Initial Address

The name of this corporation is ACE STAIR PARTS, INC. and initial address of the corporation is 21749 Masters Circle, Estero, Florida 33928.

ARTICLE II. Duration

This corporation shall exist perpetually commencing on the date of execution and acknowledgment of these articles.

ARTICLE III. Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV. Capital Stock
