I recently spoke with you concerning my small business account and renewal. I am writing this letter to inform the state office that I received the first letter in February and sent in a check in the amount of 150.00 to the Division of Corporations, Check Number: 1239. It was cleared on February 16th, 2005 and I also sent an updated annual report with our business change. Since that time, I assumed that everything was taken care of. I also had sent in this information back in February before the renewal deadline as stated in the annual report form.

In July, I received another annual report from the Division of Corporations that was forwarded from my old "Rue De Bayonne" address. It is no telling how long that was sent, since we moved back last September. We were on Vacation in Europe for 17 days and this past weekend (07-30-05) we opened our mail to find it. I have spoken with Jessica (10am) and also Michelle (3:15pm) on August 3, 2005 regarding the check and why the business address wasn't changed. I also have contacted Wachovia and they were unable to help me find a cleared check. The bank stated that they could not retrieve a check more than 3 months from a free checking account. They also were under changes with a buy out at that time and that may also be a reason why the check was not able to retrieve from the branches computers.
