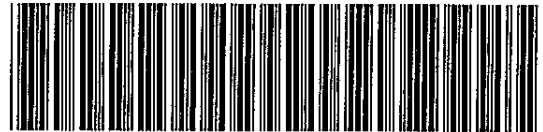



In corporation with Chapter 607 and/or 621, Florida Statutes, the undersigned hereby states:

**ARTICLE I — NAME**

The name of this corporation is **DAHAN, INC.**

**ARTICLE II — PRINCIPAL OFFICE**

The principal place of business and mailing address is **2305 ABALONE AVENUE, ORLANDO, FL 32833.**

**ARTICLE III — DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

**ARTICLE IV — PURPOSE**

This corporation is organized for the purpose of operating a restaurant, food and catering service and transacting any or all lawful business.
