In compliance with Chapter 607 and/or Chapter 621, Florida Statutes, the undersigned subscriber, Christopher J. Stanley, a natural person competent to contract, hereby forms a professional corporation under the laws of the State of Florida, and adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the professional corporation shall be **Christopher J. Stanley, M.D., P.A.**

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The initial principal place of business of this professional corporation in the State of Florida shall be 311 N. Clyde Morris Blvd., No.180, Daytona Beach, Florida 32114. The Board of Directors from time to time may move the principal office to any other address in Florida.

ARTICLE III - NATURE OF BUSINESS

The general purposes for which the professional corporation is organized are:

1. To render professional medical services to the general public and, more specifically, obstetrical and gynecological services to the general public;
2. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares of common stock that this professional corporation is authorized to have outstanding at any one time is one hundred (100) shares, having a par value of One U.S. Dollar (\$1.00) per share.

ARTICLE V - REGISTERED AGENT


This corporation reserves the right to amend or repeal any provisions contained in






