Pursuant to the provisions of Section 607.1006, Florida Statutes, Stephen Zweibach, M.D., P.A. (the "Corporation") has adopted the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is Stephen Zweibach, M.D., P.A.

SECOND: The following amendment to the Articles of Incorporation was adopted by the Corporation:


Article One, in its entirety, of the Articles of Incorporation of the Corporation be and hereby is revoked, declared null and void and of no further effect and, in lieu thereof, the following article is adopted, approved and ratified:

ARTICLE ONE

The name of the Corporation is Zweibach & Champion, M.D.s, P.A.

THIRD: The foregoing amendment was approved and adopted by the Unanimous Written Consent of the Shareholders and Board of Directors pursuant to Sections 607.0704 and 607.0821, Florida Statutes, dated August 28, 2012. The number of votes cast for the approval and adoption of the amendment by the Shareholders was sufficient for approval.
