AMENDED AND RESTATED ARTICLES OF INCORPORATION OF A&A PLUS HOLDINGS, INC.



Pursuant to Section 607.1007 of the Florida Statutes, A&A Plus Holdings, Inc., a Florida corporation (the "Corporation"), certifies that:

- The Amended and Restated Articles of Incorporation were duly adopted by the Board 1. of Directors and its sole shareholder as November 3, 2003;
 - 2. The Articles of Incorporation are amended in its entirety to read as follows:

ARTICLE I

NAME

The name and the principal place of business and mailing address of this Corporation shall be:

ARTICLE II

NATURE OF BUSINESS

The general purpose for which this Corporation is organized is to transact any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.
