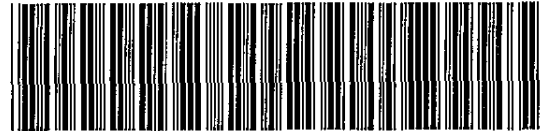

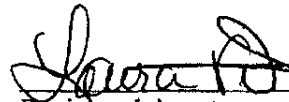
**Article VII – Registered Agent**

Article XIII – Amendment

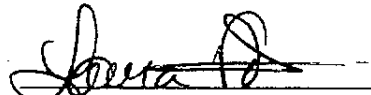
