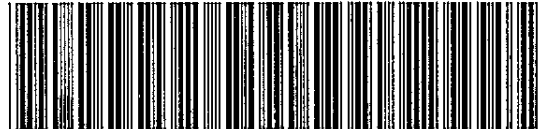

Indemnification


