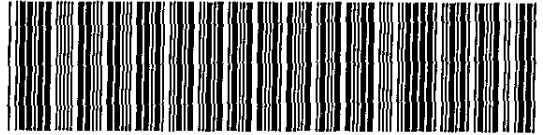

ARTICLE I - NAME

The name of this corporation is NM8 Productions, Inc.

ARTICLE II - PRINCIPAL OFFICE
