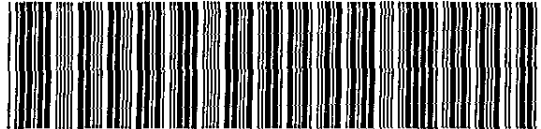

ARTICLE I. NAME

The name of this corporation is CHEER PLUS ATHLETICS, INC.

ARTICLE II. DURATION

This corporation shall commence March 1, 2003, and shall have perpetual existence.

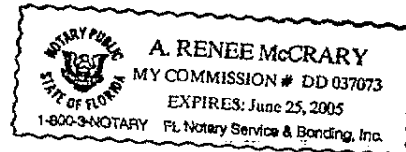
