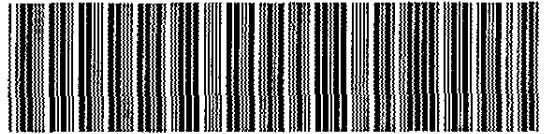

OFFICERS AND DIRECTORS




