ARTICLES OF INCORPORATION

OF

SHORELINE TITLE INSURANCE OF VOLUSIA COUNTY, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be: Shoreline Title Insurance of Volusia County, Inc. The principal place of business of this corporation shall be 101 E. Yelkca Terrace, Suite F, Edgewater, Florida 32132, and the mailing address of business shall be Post Office Box 582, Edgewater, FL 32132.

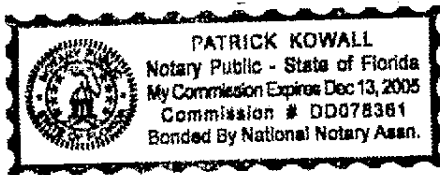
