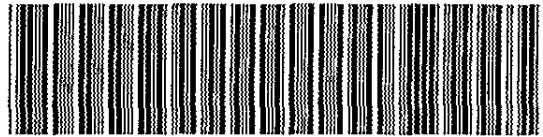

OF

103 Works, Inc.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I - NAME

The name of this corporation is 103 Works, Inc..

ARTICLE II - EXISTENCE

The existence of this corporation shall begin upon the filing of the Articles of Incorporation.

ARTICLE XIII - INITIAL SHAREHOLDERS

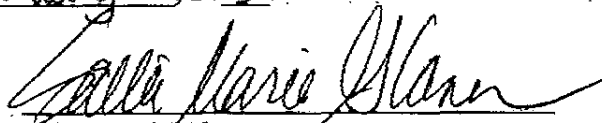

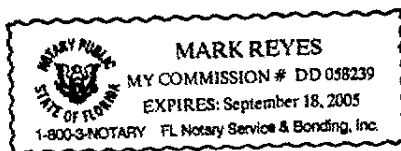


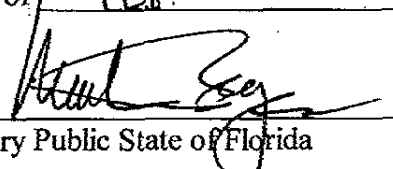
