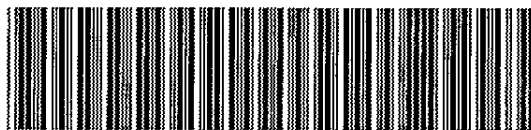

ARTICLE ONE

Name

Principal Office and Address
