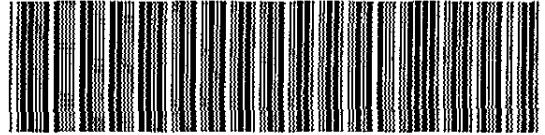

NAME
