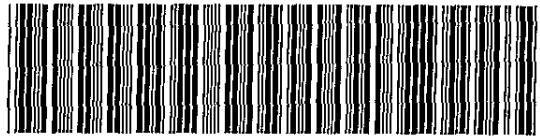

ARTICLE I. NAME

The name of this Corporation is
D V CONTRACTING, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

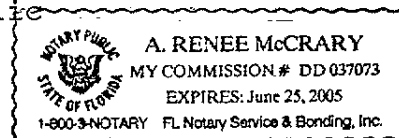
