

ARTICLES OF INCORPORATION DAVE & JUDY RUIZ AUTO BODY, INC.

ARTICLE I

The name of this corporation is DAVE & JUDY RUIZ AUTO BODY, INC. Whose principal address is 1400 NW 58 Terrace, Sunrise, Florida 33313

ARTICLE II

The general nature of the business to be transacted by this corporation is to engage in the auto body shop, a business permitted under the laws of the State of Florida.

ARTICLE III

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is ONE THOUSAND (1,000) shares of common stock having a par value of ONE DOLLAR (\$1.00) per share.

ARTICLE IV

This Corporation shall have perpetual existence commencing upon the filing of these Articles of Incorporation.

ARTICLE V

The Registered Agent and the street address of the initial Registered Office of this Corporation in the State of Florida shall be:

The Board of Directors from time to time may move the Registered Office to any other address in the State of Florida.

ARTICLE VI
