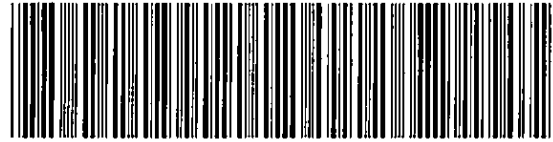

**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION OF
DE LA GUARDIA VICTORIA ARCHITECTS AND URBANISTS, INC.**

Pursuant to Sections 607.1001 and 607.1006, Florida Statutes, De La Guardia Victoria Architects and Urbanists, Inc., a Florida corporation (the "Corporation"), hereby adopts these Articles of Amendment to its Articles of Incorporation (the "Amendment") for the purpose of amending its Articles of Incorporation as follows:

1. The name of the Corporation is De La Guardia Victoria Architects and Urbanists, Inc.
2. This Amendment was approved by the shareholders of the Corporation as of the 10th day of August, 2023, in the manner prescribed by law under Section 607.1003(5), Fla. Stat. The number of votes cast for this Amendment was sufficient for approval.
3. Article Three of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and the following is inserted in lieu thereof:


**ARTICLE THREE
CAPITALIZATION**

The aggregate number of shares which the Corporation shall have the authority to issue shall be Two Thousand (2,000) shares of common stock of the Corporation, par value of \$0.01 per share (the "Common Stock"), of which (a) Five (5) shares shall be entitled to vote on all matters presented to the shareholders of the Corporation with each share entitled to one vote (the "Voting Common Stock") and (b) One Thousand Nine Hundred Ninety-Five (1,995) shares shall not be entitled to vote on any matters presented to the Shareholders or any notice with respect thereto (the "Nonvoting Common Stock"). The Voting Common Shares and the Nonvoting Common Shares shall have the same identical rights to receive distributions and liquidating proceeds in accordance with Treasury Regulation Section 1.1361-1(l)(1) such that it only has one class of stock for Federal income tax purposes and qualifying as a Subchapter S corporation.

This Amendment will become effective on the filing date hereof.
