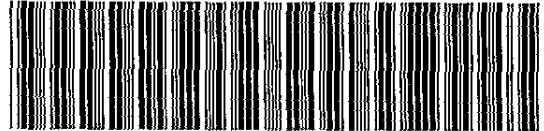

### **ARTICLE III      PURPOSE:**

(a) To acquire, construct, purchase, rent, own and operate telephone lines and telephone stations including but not limited to the sale of long distance, local and specialized telephone and communication services for industrial, commercial and residential uses; to engage in the promotion of long distance and other telephone and communication enterprises; act as agents, managers, brokers, liquidators and otherwise carry on the business of the promotion of communication services.

(b) To manufacture, purchase, or otherwise acquire, hold, mortgage, pledge, sell, transfer, or in any manner encumber or dispose of goods, wares, merchandise, implements and other personal property or equipment of every kind.

(c) To buy, sell, deal in, lease, rent, hold or improve real estate and the fixtures and personal property incidental thereto or connected therewith, and with that end in view to acquire, by purchase, lease, hire or otherwise, lands, tenements, hereditaments, or any interest therein, and to improve the same, and generally to hold, manage, deal with and improve the property of the Corporation, and to sell, rent, lease, mortgage, pledge or otherwise dispose of the lands, tenements and hereditaments or other property of the Corporation.

(d) To manufacture, purchase or otherwise acquire goods, wares, merchandise and personal property of every class and description, and to hold, own, sell, or otherwise dispose of, trade, deal in and deal with the same.

(e) In furtherance and not in limitation of the general powers conferred by the laws of the State of Florida and of the purposes hereinbefore stated, it is hereby expressly provided that the Corporation shall have the power to do any and all things set forth as its objects, to the same extent and as fully as a natural person might or could do, as principal, agent, contractor, or otherwise, and alone or jointly with any other corporation, association, firm or person, and to do all and everything necessary and incidental for the accomplishment of the purposes or the attainment of any one or more of the objects herein enumerated or incidental for the protection and benefit of the Corporation. Furthermore, the objects and purposes specified in each of the clauses of this article shall be regarded as independent objects and purposes, and that said clauses shall be construed as both purposes and powers.
