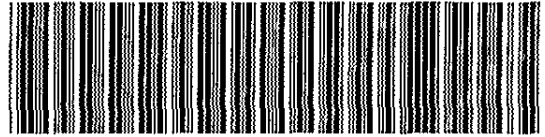

**ARTICLES OF INCORPORATION**

**OF**

**JEROME A. SAVLOV, P.A.**

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I**

**NAME**

The name of the corporation is Jerome A. Savlov, P.A. and its address is 1711 Street, Andrews Road, Hollywood, FL 33021.

**ARTICLE II**

**DURATION**

The duration of the corporation is perpetual.

**ARTICLE III**

**PURPOSE**

The specific purposes for which the corporation is organized are:

- (1) To act as a licensed real estate salesman and as a licensed real estate broker.
- (2) To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

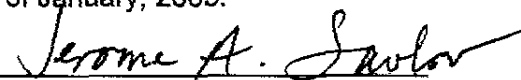

### INDEMNIFICATION

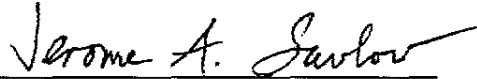
