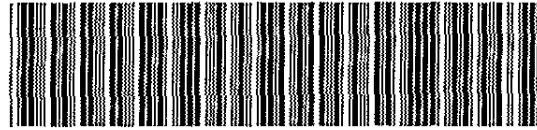

**ARTICLE ONE**

The name of this corporation is PORTABLE PRESSURE SYSTEMS, INC. and the mailing address of the corporation shall be 11985 Amedicus Lane, Fort Myers, FL 33907.

**ARTICLE TWO**

The date of the commencement of corporate existence of the corporation shall be the date these Articles are filed with the Secretary of State.





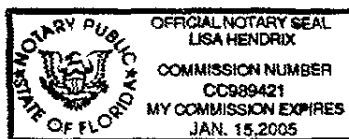
