### ARTICLES OF INCORPORATION

OF

The name of the corporation is Art Glass Gallery, Inc. at 578 Highway A1A, Satellite Beach, FL 32937 (Principal Office of Registered Agent).

# ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.
