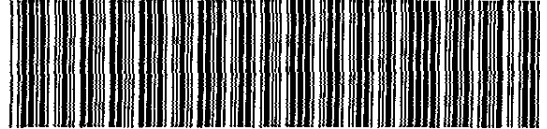

ARTICLES OF INCORPORATION
Of

TO: STATE CORPORATION COMMISSION:

The undersigned natural person of the age of twenty-one years or more, acting as incorporator, adopts the following Articles of Incorporation pursuant to the State Corporations Act:

- FIRST: The name of the corporation is Tim's Residential Repair, INC.
Corporation Address is: 1360 North East 23rd Ave. # 1A
Pompano Beach, Florida. 33062.
- SECOND: The period of duration is perpetual.
- THIRD: The Corporation is organized and will be operated exclusively for home repairs ie: the repair of broken doors, replacement of light bulbs, and recepticals, general handyman type jobs. Specifically, the corporation is organized to work under the direction of the private homeowner. 
